Fall 2021 Campus Status Approach	<ul style="list-style-type: none"> <li>• Baseline intent is for a full in person experience (Plan A)</li> <li>• Students and employees are required to be vaccinated unless approved by exemption</li> <li>• Programs function with pre-COVID approach – including events</li> <li>• Offices are fully staffed on campus with some flexibility</li> <li>• Spatial occupancies return to pre-COVID status</li> <li>• Limited canopies will be provided to support outdoor gatherings</li> <li>• Prepare for transition to Plan B or C if needed (requires detailed plans for functional areas)</li> </ul>
